PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: Delineation of Ecologically sensitive Areas (ESA) in Western Ghat Region of Karnataka State.

Read: 1) Draft Gazetted Notification, S.O.733(E) dated 10/03/2014 of Ministry of Environment and Forests, Government of India for declaring Ecologically Sensitive Area(ESA) in Western Ghats States.

2) D.O letter dated 09/06/2014, from Dr V.Rajagopalan, Secretary to Govt., of India, MoEF addressed to Sri Kaushik Mukherjee, Chief Secretary to Govt., of Karnataka.

Preamble:

In vide Draft Gazetted Notification dated: 10/03/2014 of Ministry of Environment of India referred (1) above, Kasturirangan Committee (Highlevel Working Committee—HLWG) has made recommendations regarding delineation of Ecologically sensitive Areas (ESA) in Western Ghat region of the Country and various activities to be prohibited and regulated in the Eco-sensitive Areas in the region. A Draft Gazette Notification, S.O.733(E) dated 10/03/2014 was issued by Ministry of Environment and Forests, Government of India in the matter and the objections and suggestions were called for with in 60 days from the date on which copies of the Gazette of this notification are made available to the public. The Government of Karnataka has communicated its stand/opinion regarding HLWG's recommendations and the subsequent notification issued by Ministry of Environment and Forests, Government of India, referred above, based on the recommendations of the Cabinet Sub-Committee under the Chairmanship of the Hon'ble Forest Minister for the purpose.

Ministry of Environment & Forests, Government of India vide the ref (2) above has communicated that an opportunity is given to the States of Western Ghat Region (except Kerala) for undertaking the exercise of demarcating ESA within their jurisdiction by physical verification as was done in Kerala State.

In Karnataka state too, many representations and complaints were received regarding inclusion of cultivated areas, plantation areas and human habitations in ESAs, apprehending that restrictions so imposed in ESAs may affect the livelihoods of farmers and common people in the region adversely.

On perusal of the recommendations of the Expert Committee Constituted RSITY BOARD by the Kerala Government in the matter, it is observed that field teams have NGALORE. been constituted for physical verification of the ESAs recommended by HLWG, 902 so that human habitations, farmlands and plantations are excluded from ESAs,

so that only natural landscapes are included in ESAs. Physical verification of maps and field data by field committees, has facilitated the State Committee to finalise its recommendations on the HLWG report.

Government has examined the issue in detail and hence orders as hereunder.

The following State level Expert Committee is constituted to examine closely the Ecologically Sensitive Areas as recommended by High level Working Group on Western Ghats (herein after HLWG), keeping in view the natural landscapes, farmlands, plantations and human habitations and to suggest the appropriate areas to be included in Ecologically Sensitive areas, with balanced approach for conservation of ecology of Western Ghats in the state and the livelihood issues in the area coupled with genuine development/essential infrastructure needs in the area.

Terms of reference to the State Level Expert Committee (SLEC):

1) SLEC will work-out methodologies for physical verification Ecologically Sensitive Areas(ESA) delineated by HLWG and communicate them to the District Level Committees. SLEC may consider the approach adopted by the Kerala state, but it has also to dovetail the methodology to be followed in the state, as number ESA villages is around 1576 in Karnataka as against 123 in Kerala state.

- 2) SLEC will have District-level interactive sessions to have feedback from people's representatives, farmers organisations, Voluntary organisations and officials regarding ESAs proposed by HLWG and notified by MoEF, Gol on 10th March, 2014.
- 3) The Committee will examine critically the ESAs from the point of conservation of bio-diversity rich Western Ghat areas and also the likely impacts of various proposed restrictions on the lives of --common people/genuine developmental needs of the region.
 - SLEC will finalise its Report with recommendations, in TWO MONTHS time from the issue of this order.

The following District Level Committees are constituted for Belgaum, Uttara Kannada, Dakshina Kannada, Udupi, Chikmagalore, Shimoga, Hassan, Madikeri, Mysore and Chamarja Nagara Districts to organise the physical verification of Eco-sensitive areas.

Terms of reference to the District Level Committees (DLC):

 DLC will organise physical verification of the ESAs by Field teams as per the guidelines of SLEC. Field teams will verify and mark, Natural Landscape in the village (notified forests, thickly wooded areas), agricultural lands, Plantation crops (Areca nut, Coffee, Rubber, Cashew-nut etc), Human habitations on Village maps for ESA villages as recommended by HLWG.

- 2) DLC will give take up necessary steps to create public awareness about the ESAs and various recommendations of HLWG in the respective Districts.
- 3) DLC will receive representations from peoples representatives, farmer organisations, voluntary organisations etc, analyse them and keep district-level summary for consideration SLEC.
- DLC will facilitate conduct of District-level interactive sessions of SLEC with people representatives, Farmer representatives, Voluntary organisations etc.,
- 5) DLC will provide necessary logistic support to the SLEC during its visit to the district.
- 6) DLC will finalise and provide ESA village-wise maps and district wise tabulation to SLEC, based on physical verification by field teams.

SLEC will have the GIS based spatial analysis support from Karnataka State Remote Sensing Application Centre (KSRSAC), ICT cell and Working plan wing of the Karnataka Forest Department. District level Committee will organise required village maps and taluk maps for physical verification of ESAs.
